



NORTH INDIA SOLAR SUMMIT -2017 REPORT



Preamble:

As early as 2013 Indian Industries Association (IIA) realised the need and potential of Solar Power generation and utilisation. IIA also realised that maximum potential for Solar Power lies in North India with Uttar Pradesh as a leading state.

India's Solar potential is greater than 750 GW (750000 MW). India's Energy Security Scenario's 2047 shows a possibility of 479 GW of Solar PV by 2047.

Government of India's target is to install 100GW Solar Enegy capacity by 2022 out of which 40 GW is expected to be achieved through deployment of decentralised Rooftop projects, 40 GW through Utility Scale Solar Plants and 20 QW through Ultra Mega Solar Plants.

Out of total target of 100GW Solar Power capacity to be added by 2022, North Indian States (J&K, H.P, UK, Punjab, Haryana, Chandigarh, Delhi, U.P and Rajasthan) share is targeted at 31.12 GW. Traget for Uttar Pradesh is 10.697 GW which accounts for more than 1/10th of the National Target.

In view of the huge potential (much more than any other region of the Country) for Solar Energy in North India as is evident from the data stated above, IIA decided to organise "NORTH INDIA SOLAR SUMMITT" (NISS) in Lucknow.

First edition of NISS was organised in March 2014. Since then the evnt is organised every year. The forth Edition of NISS was organised successfully from 3rd to 5th March 2017 at IIA Bhawan Grounds, Vibhuti Khand, Gomti Nagar, Lucknow.

uring the second consecutive day of North India Solar Summit-2017 a NATIONAL SOLAR CONCLAVE- 2017 was organized by IIA which marked the presence of Smt. Jyoti Neeraj Khiarwal I.A.S. Additional Secretary- Energy Uttarakhand and Director UREDA who inaugurated the Conclave as Chief Guest and Smt Sangeeta Singh I.A.S. Director-UPNEDA as Guest of







Honor, General Manager (Operation Services) NTPC Limited, Shri Anil Mishra, National Project Manager, UNIDO, Shri Sanjay Srivastava-Secretary UPERC and various other high level dignitaries.

hri Manish Goel, President-IIA in his welcome address said that the basic objectives of organizing National Solar Conclave is to provide one stop solution of all the requirements related to Solar and be aware about all the latest techniques. Smt Jyoti Neeraj Khiarwal I.A.S. Additional Secretary-Energy Uttarakhand and Director UREDA Chief Guest for the Conclave said that the dynamics of solar rooftop is different in different states depending upon the availability of power and the costs at which they are available and the amount of subsidy available for them. The challenges faced in Net metering and Gross Metering system were explained by her in detail. She said that solar should not be limited by RPO

Obligation, but must be self sustaining and income generating. An innovative plan of generating solar power through floating solar panels in the 22 square kilometre area of Tehri Dam in Uttarakhand was shared by Smt Khairwal where in more than 2000 megawatt solar power will be generated in the Tehri Hydro project.

Smt Sangeeta Singh I.A.S. Director-UPNEDA appreciated the efforts of IIA for successfully organizing the 4th Edition of NISS. She also explained about the efforts that UPNEDA is making for the upliftment of this sector. She was pleased to find that a large number of users are interested to set up solar power plants and are enthusiastic about Solar Thermal Applications (CST) as well. She said that UPNEDA is also making efforts to create awareness about CST. Solar rooftop, PV technique and subsidies available for solar sector were discussed in detail and a thorough brainstorming on these topics was done. She thanked IIA for making UPNEDA a part for this mega event.

shared that Central Government is already giving lot of incentives for propagating renewable energy sector. He said that Concentrating Solar Thermal (CST) technology plays a very important part today for its applications in the industries. As on date Solar thermal technology has become very common for industries and also for cooking applications such as in Temples and Gurudwaras, Hotels and medical institutions for sterilization purposes etc. This technology has multiple uses and Government gives various financial and technical supports. Accelerated depreciation is also available to profit making organisations. Some International support of varied percentages on the basis of merit of the project is also awarded. The technology is easy to use and has an affordable cost. Therefore it is the apt time for industries to adapt this technology and avail support from the Government.

Shri Arup Kumar GM- SIDBI praised IIA for constantly making efforts to promote the usage of Solar Energy. He gave a power point presentation on the Initiatives of SIDBI to promote Solar Energy.
